#### A) General Accounting Policies

The financial statements presented are for the reporting entity Ethnic Council Wellington Incorporated). The financial statements have been prepared in accordance with requirements of the generally accepted accounting policies in New Zealand. The financial statements have been prepared on the basis of historical cost.
