PRA Committee meeting - April 2014

At this month's meeting we under took planning for the upcoming 20 May 2014 Annual General Meeting and:

- The PRA recognised Alan Gray for his contribution to the Pauatahanui Residents Association and the local community. For the last decade Alan has significantly contributed to the success of the Committee's work and previously with other community bodies. Alan is stepping down as a member of the PRA Management Committee at the May AGM. Alan was made a life member of the PRA at the meeting. We thank him on behalf of residents and we welcome him keeping a close interest in matters of importance to our community.
- PCC will select a Commissioner on 23
 April to hear the GroundUp Café notified resource consent, covering retrospective approval of café alterations.

- Winstones Aggregates have sought an extension of time from the Environment Court to enable them to further assess options to access the proposed cleanfill site, with a view to potentially proposing a new design (that falls within the scope of the original application).
- The Northern Growth Area Plan is unlikely to impact Pauatahanui as the focus of the plan is the development of the area between Plimmerton and Pukerua Bay.
- To coincide with NZTA's consultation on lowering the speed limit on SH58 to 8okm/h, Porirua City Council has just approved consultation to commence on the review of speed limits from 10okm/h to 7okm/h on rural roads off State Highway 58, including Bradey Road, Belmont Road, Flightys Road, Murphys Road, Mulhern Road and Moonshine Road.
