# Water & Sewerage Reticulation in Pauatahanui Village

After many years of planning, work to connect water and sewerage to properties in Pauatahanui village has finally been completed and was officially opened on 26 June 2014.

Water & Sewerage reticulation scheme for Pauatahanui Village was one of the key priorities raised in the last Pauatahanui Village Plan.

The project was seen by both Porirua City Council and local residents as an important step in protecting the health of the Pauatahanui Inlet.

Many of the properties within the village were on low-lying land that was

susceptible to a high water table. They were also too small to adequately deal



with on-site wastewater disposal (i.e. septic tanks). Twenty-one Pauatahanui

properties, including Pauatahanui School and preschool, have now been connected through the scheme, with half the capital cost of the project paid for by the property owners.

## PRA Committee meeting - July 2014

This month's meeting the Committee covered a number of topics, including:

- Saturday 30 August get your copy of 'Pauatahanui, A Local History' from the Whitby Mall in time for Father's Day. Your purchase from the Mall will support the PRA's local history activities and raise money for the Scots College history trip to Gallipoli in 2015. The book can also be purchased anytime from Pataka Gallery, Paper Plus (Porirua and Lower Hutt), P&Z Porirua Resene, Unity Bookshop Wellington and online at:

- The Hearing over the notified resource consent application of Darryl Ellis (to undertake an expansion of the GroundUp Café, including additional and alterations

- to the existing building and increased seating capacity) is now scheduled for October 2014. PRA is writing to PCC to indicate concerns that the decision is not being made within reasonable timeframes.
- → You may have noticed there's been a lot of work done on the carpark pedestrian safety project just south of the Lighthouse Cinema. The area is well used, especially by people walking from Whitby. This is a good example of our Village Plan coming to life. Thank you to Anna Dellow and Claire Giblin for their tireless work on this project, which has made it happen.
- The PRA website will soon have a new 'Local Information' heading under the menu, which will include local business and service directories as well as an A-Z of information for local residents

- covering links to topics such as waste water management, rural fire service. Continue to let us know what you would like to see on the website.
- The electronic survey was a great success, with 40 respondents. Please refer to the back of the newsletter for a summary of the results.
- NZTA have announced the contract for the 27km Transmission Gully project has been awarded to the Wellington Gateway Partnership. The aim is to have it open for traffic by 2020.
