#### PRA meeting - June 2014

June was the first meeting of the new management committee voted in at last month's AGM. We welcomed Andy Manning to the Committee and we covered a number of topics, including:

- Sales of the history book 'Pauatahanui, A Local History', continue at a steady pace. There will be a special sales table at Whitby Mall on Saturday 30 August, just in time for Father's Day on 7 September. Your purchase from the Mall will support the PRA's local history activities and raise money for the Scots College history trip to Gallipoli in 2015. - The Porirua City Council (PCC) has advised submitters on the resource consent application to extend GroundUp Café, that after seeking legal advice Council has been advised that it would be best to delay the independent hearing until after the High Court decision between the owner of the site and the owners of the Pauatahanui General Store has been released.
- The project to improve the safety of the Te Ara Piko/Whitby Walkway link (Lighthouse car park) will commence shortly, with the impacts of the works being discussed with those most affected.

- The 2014/15 Village Planning programme projects will include a history trail, bus shelter for the school and consideration of a welcome to Pauatahanui sign.

## Yard Maps -Technology for the birds!



Wouldn't it be great to have a bird's eye view of our area and see how our property contributes to the whole ecosystem around us? Scenic

reserves are fantastic but when private properties take up 90 % of the area, creating a simple bird corridor becomes almost impossible. With so many birds on the endangered and critical list, we can no longer expect "someone else" to "do something".

and their own drop down boxes to map your own property with its vegetation,

building areas, bird friendly areas etc. They

collate this information to produce a map of the environment around your section or "yard". Everyone views their property as it really is a part of a bigger ecosystem. The aim is that you are then able to alter and plant your property to provide what is missing in your area. Birds need food, shelter and protection all year round and depend on a variety of species of trees, shrubs and deep humus to provide that. You will be asked to complete a survey so obviously there is a team writing master theses on this innovation. There is no plant or bird list for NZ but I hope that it will be only a matter of time before we can ride on their coat tails and produce one for this area... wouldn't that be great.

## Onsite Wastewater Systems Licensing



From 1 April 2011 PCC introduced a system of Certificate of Fitness and licensing for On-site wastewater disposal (or septic tanks), requiring landowners to meet set conditions depending on the type of septic tank or disposal system. Recently PRA has heard some queries regarding how the relicensing is being implemented.

Following discussion at this month's meeting the PRA have decided to write to Council to request a copy of the Council process and protocols for licensing and renewal.
