Community Water Station

Have you ever wondered what the large shipping container, labelled "Community Water Station", at the end of Belmont Road is for? The PRA has investigated and here's what we've learned so far.

- The Community Water Station is part of the Wellington Region Emergency Response Office (WREMO) services whose role is to co-ordinate Civil Defence and Emergency Management services on behalf of the nine councils in the Wellington region.
- WREMO manages the drinking water, wastewater, and stormwater services for our local Councils.
- There are three community water stations within the Porirua City Council boundary. The Pāuatahanui Community Water Station (SH58), the Takapuwahia Community Water Station and the Postgate Park Community Water Station.
- The emergency network would supply water from day eight after a major earthquake, with the aim of being able to supply every Wellingtonian with 20 litres of water every day.
- The container has a 20,000 litre emergency water bladder inside that can be used to fill smaller water bladders that would be transported where it is needed.
- It is essentially "a water treatment plant in a box" with the water supplied treated to NZ Drinking Water Standards.
- In an emergency, the station would be unlocked by Wellington Water however it would be up to the local Community hub/s to determine how it might be distributed. The water wouldn't necessarily be used by our community. It might be trucked to somewhere where it is most needed.
